



Meeple Movers Summer Camps Parent Guide and Camper Code of Conduct

For a fun and safe experience for everyone at Meeple Movers Summer Camps, we all agree to follow these guidelines.

PARENT/GUARDIAN/EMERGENCY CONTACT AGREES TO:

Check-in and Check-out Procedures:

- Arrival time for camp is 12:00pm. Please come inside and sign in your camper with staff.
- Only authorized adults listed on the camper's registration form are permitted to pick up children. To guarantee the safety of the children, staff may ask for photo identification from the person picking up a child, especially if they are not known to the staff.
- Pick up time is between 4:00pm and 4:30pm. Please come inside and sign out your camper with staff.

Late Pick-Up:

- If you anticipate being late, please call (352-572-5637) to inform the camp staff.
- Late pick-ups will be documented.
- We do not have after-hour care. Barring an unforeseen emergency, if you are late picking up your camper, you could potentially incur additional fees. Beyond a 15 minute grace-period, any late pick ups will be charged \$25 per half hour additional fee. Consistent tardiness without communication might even lead to removal from the program in some cases.
- After 30 minutes of late pick up, and after attempting to contact all listed authorized adults, we will contact the non emergency police line.

It's crucial for parents to adhere to these schedules to maintain the camp's daily structure, ensure adequate supervision and to keep any additional costs down for the camp since the Camp Directors are paid by the hour.

- **Be Punctual:** Arriving on time for both drop-off and pick-up helps the camp run smoothly and minimizes disruption for the children and staff.
- **Follow Procedures:** Adhere to the camp's established drop-off and pick-up procedures to ensure the safety and efficiency of the process.
- **Communicate Changes:** If there are any changes to who will be picking up your child or if you anticipate being late, inform the camp staff as soon as possible.
- **Be Patient:** During peak drop-off and pick-up times, there might be some congestion. Patience and cooperation will help the process go smoothly for everyone.

CAMPER AGREES TO:

Safety First!

1. **I will listen carefully to all instructions from the Summer Camp Director and staff.** This includes rules for games, activities, and general safety.
2. **I will stay within the designated camp areas.** I will not wander off on my own without permission from a staff member.

3. **I will immediately tell a staff member if I feel unwell, hurt, or see something unsafe.** This helps us keep everyone healthy and protected.
4. **I will treat all game pieces, equipment, and the game store with respect.** This means being careful with them so everyone can enjoy them.
5. **I understand that running and rough play are not allowed inside the game store.** This helps prevent accidents.

Respect for Others:

6. **I understand that bullying, teasing, or any form of harassment is not allowed.**
7. **I will be kind and respectful to all campers and staff. I will listen to others when they are speaking and wait my turn to share.** This includes using polite language and treating everyone fairly.
8. **I will try to trade my screen time for accessing a whole new level of fun.** Staying off my phone during game time is important so I can stay connected.

Following Directions:

9. **I will follow the directions of the Summer Camp Director and all camp staff.** They are here to help us have a great and safe time.
10. **If I am unsure about something, I will ask a staff member for clarification.** It's always better to ask than to guess.
11. **I understand that if I consistently do not follow the Code of Conduct, there may be consequences of being unable to return to camp.** Our goal is for everyone to have a positive experience.
